On behalf of Energy Policy Advocates (“EPA”), recognized by the Internal Revenue Service as a non-profit public policy institute under § 501(c)(3) of the Internal Revenue Code, and numerous federal agencies as a media outlet for FOIA purposes, and pursuant to the California Government Code §§ 6250 *et seq.*, please provide us within 10 business days copies of the following public records:

1) copies of any Annual Reporting Form for Category I & II Outside Professional Activities, and Additional Teaching Activities, and/or the Annual Reporting Form for Category I & II Compensated Outside Professional Activities, filed by or for each of the current co-executive directors of the Emmett Center on Climate Change and the Environment UCLA Law School, Prof. Sean Hecht and Cara Horowitz, for the years 2017, 2018, 2019, 2020, and/or 2021 (these are referenced in APM-025 Conflict of Commitment and Outside Activities of Faculty Members, e.g., in 025-6, Responsibility (b) Faculty, and in 025-10 Guidelines (b) Disclosure requirements);

2) copies of any consulting, non-disclosure, representation, confidentially and/or common interest or other agreement whose parties include (but are not necessarily limited to) the UCLA Law School *and/or* Emmett Center on Climate Change and the Environment *and* Sher Edling, LLP, dated or in effect during one or more the years from 2016 through 2021, inclusive;

3) copies of any records terminating any consulting, non-disclosure, representation, confidentially and/or common interest or other agreement whose parties include (but are not necessarily limited to) the UCLA Law School *and/or* Emmett Center on Climate Change and the Environment *and* Sher Edling, LLP, dated or in effect during one or more the years from 2016 through 2021, inclusive; and

4) copies of any records reflecting or discussing the work the Law School¹ has done on climate nuisance litigation, which are dated at any time during one or more the years from 2016 through 2021, inclusive.²

Our request seeks to further illuminate the participation of the University and its faculty, including outside funding of faculty and the use of the faculty position, to assist private activist and tort litigation campaigns targeting private parties.

This request is being made in the public interest and furnishing this information will benefit the public's understanding of public institutions and their role in coordinating with activist and litigation campaigns.

As this request is made on behalf of a nonprofit and nonpartisan organization that works to educate the public on the use of public institutions by and toward private ends including,
